- **6.** "Use" means the lawful, authorized, restricted, non-exclusive, limited, and revocable right or license to use the Product Mark

7.1 Design of NABCB Accreditation Symbol and IAF MLA / ILAC MRA Mark:

NABCB Accreditation Symbol is a combination of NABCB Logo with unique accreditation number as granted to OneCert written below the NABCB Logo. The design of the NABCB logo is enclosed at Appendix 'A' and the NABCB Accreditation Symbol and the Combined IAF MLA / ILAC MRA Mark is in Appendix 'B'. The design specifies the proportions of the logo and the colour combinations in which it can be reproduced. Design of other mark / symbol, like the Combined IAF MLA Mark for certification bodies / validation/verification bodies and the ILAC MRA Mark for inspection bodies is permitted for use, based on specific requirements as described in the latest versions of IAF MLA Mark document (IAF ML 2) and ILAC MRA Mark document (ILAC R7) respectively.

The Combined IAF MLA / ILAC MRA Mark is subject to specific agreement signed by OneCert with NABCB.

7.2 Reproduction of logo/Symbol

7.3 Use of NABCB Accreditation Symbol and IAF MLA / ILAC MRA Mark

The use of NABCB Accreditation Symbol and the Combined IAF MLA or ILAC MRA Mark as relevant to OneCert, and the NABCB Accreditation Symbol by the client organizations of OneCert, if permitted, will be under the control and supervision of the OneCert. 7.3.1 Content, Size and Reproduction

7.3.2 Conditions for Use of NABCB Accreditation Symbol and IAF MLA /ILAC MRA Mark

OneCert International can only uses the accreditation symbols and the IAF MLA / ILAC MRA Mark, as relevant for premises of the OneCert International and the office(s) of the CAB that are included in the accreditation granted by the NABCB. The accredited body does not make any statement regarding its accreditation that NABCB may consider misleading or unauthorized, specifically:

- a. The symbol or the IAF MLA / ILAC MRA Mark along with the reference to the standard will be used to refer the accredited status of the OneCert International and in conjunction with mark of the OneCert International to refer to the accredited certificates issued to the certified organization.


Contravention of the conditions


- 1) In case the NABCB Accreditation Symbol or the IAF MLA / ILAC MRA Mark as relevant is being used by OneCert or by the Certified client contrary to the conditions specified, then OneCert will take reasonable action and where relevant advise the concerned client organization for corrective action. In situations of repeated contraventions by the client organization, OneCert will withdraw the conformity assessment attestation. In case the OneCert does not take suitable action against the improper use of the NABCB Accreditation symbol or the IAF MLA / ILAC MRA Mark as relevant, OneCert may suspend / withdraw the Certification of Certified Client.
- 2) In case the NABCB Accreditation symbol or the IAF MLA / ILAC MRA Mark as relevant is being used contrary to the conditions by OneCert , NABCB shall take reasonable action and advise the concern to OneCert for corrective action. These conditions shall include, but not limited to incorrect or unauthorized claims of accreditation status, or misleading or unauthorized use of NABCB accreditation symbols and the NABCB accreditation symbol. Suitable actions may include, based on the severity of the contraventions, actions such as requests for corrective action, suspension, withdrawal of accreditation, publication of the transgression and, if necessary, legal action. Action on Suspension and Termination



ANNEX-2 Conditions for use of FSSC logo

Conditions for use of logo by OneCert International certified organizations:
